FINANCIAL POLICY 2021-2022

The educational program offered at Stockdale Christian School is funded on a strict operating budget. For the school to maintain fiscal stability, it is vital that each family remit tuition payments on a timely basis. Upon failure to comply with the financial agreement, parents may receive a letter from the school stating that all outstanding balances must be paid for the student(s) to continue in school. SCS reserves the right to refuse academic continuation at the first month's tuition delinquency or if no prior arrangement has been made with the Head of School. Report cards and other official documents may also be withheld until the account has been paid in full.

Registration, Tuition, Daycare charges, and any other fees are paid online using the FACTS Tuition Management System **Automatic Payment Plan**. Any other form of payment must be requested in writing and be approved by the Head of School.

NEW Student

\$450.00 (per student in K-8)

Paid when application is submitted. Fee is refundable if a student isn't accepted.

RETURNING Student

\$350.00 (per student K-8) Paid by April 14th

\$400.00 Paid between April 15th and May 14th

\$450.00 Paid after May 14th

The registration fee is used to cover the annual hard costs of textbooks, testing supplies, technology maintenance, class activities, membership in the Association of Christian Schools International (ACSI), annual accreditation dues with ACSI and WASC, maintaining student files, and a yearbook.

Monthly payments: 11 equal monthly installments paid on August 1st to June 1st.

Late fee: monthly payments are due on the 1st of each month. A \$20.00 late fee will be assessed if the payment is NOT received by 4:00pm on the 15th day of the month. Accounts past 30 days may result in student dismissed from attending classes until payment is made.

Paid in full: a \$200 discount per student, when tuition is paid in full by August 1st.

Full Pay Tuition Refund Policy:

- 100% refund if withdrawal two weeks before the first day of school
- 75% refund if withdrawal at the end of the first quarter
- 50% refund if withdrawal at the end of the second quarter
- 25% refund if withdrawal at the end of the third quarter
- No refund if withdrawal in the fourth quarter

Multiple Child discount: is calculated based on the oldest to youngest student in the family. Includes students enrolled in SCS Preschool, Elementary, and Jr. High.

Bakersfield First Assembly (BFA) members: receive a 15% discount. (Definition of Member: at least **one parent** attends church services at BFA on a regular basis, in good standing, and who contributes to BFA. (verified by the church business office.)

Incidental fees: lunch tickets, sports participation fee, band registration, and private instrumental lesson fees are all billed by school and paid directly to the school using the FACTS system.

Withdrawal Policy: a two-week advance written notification to the Head of School is necessary when withdrawing a student.

Financial Aid: families that can demonstrate a financial need may request a reduction of the annual tuition amount by applying online. SCS has contracted with an outside agency, Tuition Assistance Data Services (TADS). Apply online at www.tads.com. Requests must be submitted by May 31, 2021.

DAYCARE POLICY 2021-22

Daycare is for all students in K-8 grade who **arrive on campus before 8:00 a.m. or are on campus 15 minutes after their grade level dismissal time.** State law requires adult supervision of all students at all time when on campus. In order to provide adequate staff during these hours, it is necessary for parents to sign up if they plan to use the Daycare on a regular basis.

Every parent must complete a ***Student Emergency Form*** authorizing specific individuals who may pick up a child from daycare. Those picking up students must show personal identification and must sign the child(ren) out on the daycare check-in/check-out form. Please make sure the signature and the time are on the correct line for billing accuracy. Every effort will be made to ensure that a student leaves the school premises with only a person listed on the student emergency form or with written authorization from the parent or guardian.

Daycare is charged Annually, Daily or Hourly. The Annual charges are billed the **first** of each month; August to June. Daily and Hourly charges are calculated at the **end** of each month and billed in September to June.

Annual Rate: (paid 11 equal monthly payments August - June)

FAMILY WITH THREE STUDENTS OR MORE	\$2,750	\$250 monthly

Daily Rate: *\$16.00 per student* for 7am to 8 am and 3pm to 6pm. (not on monthly contract)

AM Drop-in Rate: *\$5.00 per hour* for 7am to 8am.

Late Fee: Students on campus after 6:00 p.m. will be charged a minimum of \$5.00 for the first five minutes and \$1.00 per minute thereafter. This amount will be added to your FACTS account.
